STAFF'S REQUEST FOR CHANGE TO THE PROCEDURAL SCHEDULE

The Utilities Division ("Staff") of the Arizona Corporation Commission ("Commission") hereby requests a modification to the procedural schedule set forth by the Administrative Law Judge ("ALJ") in the August 30, 2012 Procedural Order ("PO"). Through the course of this case Staff has propounded several sets of data requests on Far West Water & Sewer, Inc., which according the PO were due ten days of receipt. 
