
16 Through this filing, EPCOR Water Arizona, Inc. and Chaparral City Water
 17 Company (collectively, "Applicants") request that the Administrative Law Judge issue a
 18 procedural order setting a procedural conference to provide for a schedule for the
 19 processing of this matter. Applicants filed their Application in this matter on October 2,
 20 2012. Following that filing, RUCO filed for and was granted intervention. Given the
 21 intervention by RUCO and the issues presented by the Application, Applicants believe that
 22 a procedural conference is warranted to discuss the timing of any required customer
 23 notices, as well as the timing for a hearing and pre-filed testimony.
