BY THE COMMISSION:

Having considered the entire record herein and being fully advised in the premises, the Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

FINDINGS OF FACT

1. Cheryl Knaut dba CKnaut Pay Phones ("Applicant") is a sole proprietorship which has a Certificate of Convenience and Necessity ("Certificate") to provide customer-owned pay telephone ("COPT") service in the State of Arizona pursuant to Decision No. 59579 (March 26, 1996).
2. On May 13, 1998, Applicant filed an application for approval of the cancellation of its Certificate.
3. In Decision No. 55817 (December 10, 1987) the Commission found that COPT providers were public service corporations subject to the jurisdiction of the Commission.
4. The Commission in Decision No. 57797 (April 8, 1992) adopted A.A.C. R14-2-901 through R14-2-909 to regulate COPT providers.
5. In Decision No. 58535 (February 14, 1994) the Commission adopted a Generic Tariff which establishes rates and minimum service standards applicable to COPT service.
6. Pursuant to A.R.S. §40-282, the Commission may issue Decisions regarding COPT Certificates without a hearing.
