PROCEDURAL ORDER
VACATING HEARING DATE
AND PROCEDURAL DEADLINES

BY THE COMMISSION:

On March 16, 2012, Access One, Inc. ("Access One" or the "Company") filed with the Arizona Corporation Commission ("Commission") an application for approval of a Certificate of Convenience and Necessity ("CC&N") to provide resold and facilities-based local exchange telecommunications services in the State of Arizona. Access One's application also requests a determination that its proposed services are competitive in Arizona.

On June 22, 2012, Access One filed its response to Staff's First Set of Data Requests.

On October 19, 2012, the Company amended its application, requesting authority to provide only resold local exchange telecommunication services in Arizona.

On November 28, 2012, Staff filed a Staff Report recommending approval of Access One's application, subject to certain conditions.

On January 22, 2012, a Procedural Order was issued scheduling a hearing to begin on March 19, 2013, and establishing other procedural deadlines.

Pursuant to A.R.S. §40-282, the Commission may act on an application for a CC&N to provide resold telecommunication services without a hearing, or with a hearing, if one is requested by any party. Because the Company now requests Commission authorization to provide only resold local exchange, this matter may precede as a non-hearing matter. Further, a review of the Access

1 One's application does not include a completed Affidavit of Publication, demonstrating that legal
2 notice of the application has been published. Access One must comply with this requirement.

3 Accordingly, the hearing in this matter should be vacated. Further, Access One must publish
4 legal notice of its application and docket an Affidavit of Publication with the Commission.


5 IT IS THEREFORE ORDERED that the **hearing** scheduled to be held on **March 19, 2013, is**
6 **hereby vacated.**

7 IT IS FURTHER ORDERED that all procedural deadlines established in the January 22,
8 2012, Procedural Order, are hereby vacated.

9 IT IS FURTHER ORDERED that Access One, Inc. shall file, **on or before February 18,**
10 **2013,** an Affidavit of Publication with the Commission.

11 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
12 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.
