PROCEDURAL ORDER

**BY THE COMMISSION:**

On February 24, 2012, Arizona-American Water Company dba EPCOR Water Arizona, Inc. ("EPCOR Water") filed with the Arizona Corporation Commission ("Commission") an application for approval of a tariff at variance with A.A.C. R14-2-410.A.2.

On March 26, 2012, EPCOR Water filed a letter waiving the 30-day period in relation to the tariff filing.

On April 13, 2012, EPCOR Water filed a Revised Exhibit A and tariff.

On May 1, 2012, a Revised Exhibit A was filed with the Commission.

On June 1, 2012, the Commission's Utilities Division issued a Memorandum and Proposed Order. However, that Order was never adopted by the Commission.

On August 1, 2012, EPCOR Water filed a Request to Close the Docket stating that following discussions with Commission Staff, EPCOR Water agreed to re-file the Peoria Agreement at a later date in the form requested. Therefore, EPCOR Water requested that Docket No. W-01303A-12-0063 be closed.
