PROCEDURAL ORDER

BY THE COMMISSION:

On November 16, 2012, Qwest Corporation d/b/a CenturyLink-QC ("CenturyLink") filed with the Arizona Corporation Commission ("Commission") an application to set or to increase the maximum tariffed rates for certain competitive telecommunications services, pursuant to Arizona Administrative Code R14-2-1110.

On November 27, 2012, the Residential Utility Consumer Office ("RUCO") filed a Motion to Intervene.

On January 16, 2013, CenturyLink filed an Affidavit of Mailing, indicating that it has provided notice of the application to all its customers, via U.S. Mail for its customers who receive paper bills, and electronically for its customers who have elected to receive their bills in electronic format.

No objections have been filed to RUCO's intervention request. RUCO should be granted intervention.


A procedural conference should be scheduled to discuss the processing of the application.


