PROCEDURAL ORDER
MODIFYING FILING DEADLINE

BY THE COMMISSION:

On July 6, 2012, Far West Water & Sewer, Inc. ("Far West") filed the above-captioned rate application with the Arizona Corporation Commission ("Commission").

On August 30, 2012, a Rate Case Procedural Order was issued setting a hearing on the application to commence on April 22, 2013, and setting associated procedural deadlines.

Intervention has been granted to the Residential Utility Consumer Office ("RUCO"), Spartan Homes & Construction, Inc., Robert C. Gilkey, Barbara S. Gilkey, Robert Rist, Rodney Taylor, Kim Taylor, Seth Davis, Barbara Davis, and Jerry S. Durden.

On February 6, 2012, Intervenors Robert Gilkey and Barbara Gilkey filed a letter requesting an extension of time of three working days (until February 13, 2013) to file their direct testimony. The Gilkeys stated that they did not receive a response to a data request from Far West within the 10-day time frame. They also stated that Far West, Staff, and RUCO have no objection to the extension request.

IT IS THEREFORE ORDERED that the Gilkeys' request for a three-day extension of time to file their direct testimony is hereby granted. The Gilkeys' direct testimony shall be filed by no later than February 13, 2013.

IT IS FURTHER ORDERED that the extension of time granted to the Gilkeys will also

1 apply to other parties, to the extent they have not previously filed that testimony.

2 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend,
3 or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at
4 hearing.
