PROCEDURAL ORDER

BY THE COMMISSION:

On August 2, 2004, Networks US, Inc. dba CA Affinity ("Network") and Motion Telecom, Inc. ("MTI")¹ (jointly "Applicants") filed a notification with the Arizona Corporation Commission ("Commission") of an Asset Purchase Agreement whereby Network will purchase substantially all of the telecommunications assets of MTI, including but not limited to MTI's customer accounts ("Application"). The Application was signed by counsel for Network.

On August 6, 2004, a second copy of the Application was filed, signed by counsel for MTI.

On August 24, 2004, Applicants filed a letter stating that affected subscribers were notified of the change in ownership.

On December 13, 2004, MTI filed a letter in this docket stating that it is no longer doing business in Arizona, and requesting that its authority to do business as a reseller be cancelled.

On December 7, 2007, the Commission's Utilities Division ("Staff") filed a letter of Insufficiency and First Set of Data Requests.

From December 7, 2007, to present, no additional filings have been made in this docket.

An update on this docket should be filed in order to determine whether further action in this

1 docket, or in Docket No. T-04186A-03-0406, is necessary.

2 IT IS THEREFORE ORDERED that Staff shall file an update on this docket informing the
3 Commission whether further action in this docket, or in Docket No. T-04186A-03-0406, is necessary.
4 The filing shall include a recommendation on appropriate Commission action.

5 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend,
6 or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at
7 hearing.
