PROCEDURAL ORDER

BY THE COMMISSION:

On July 30, 2010, Leap Frog Telecom, LLC d/b/a Voce Telecom ("Applicant") filed with the Arizona Corporation Commission ("Commission") an Application for a Certificate of Convenience and Necessity to Provide Resold Long Distance and Local Exchange Telecommunications Services in Arizona ("Application").

On November 30, 2012, the Commission's Utilities Division Staff ("Staff") filed its Staff Report in this matter recommending denial of the Application.

On December 5, 2012, Applicant's counsel filed a Notice of Appearance and Request for Hearing, which stated the Applicant intended to file a response to the Staff Report and also requested that a hearing be scheduled. As of the date of this Procedural Order, no response to the Staff Report has been filed.

IT IS THEREFORE ORDERED that the Applicant shall file its **Response to the Staff Report no later than March 11, 2013.**

IT IS FURTHER ORDERED that Staff shall file a **Reply to the Applicant's Response no later than April 2, 2013.**

IT IS FURTHER ORDERED that a **telephonic Procedural Conference** shall commence on **April 4, 2013, at 10:00 a.m.**, and that the parties shall contact the Hearing Division on **April 3, 2013, at 602-542-4250** for further information regarding the call-in phone number. Parties may also

1 attend in person at the Commission's Tucson offices, Room 218, 400 West Congress Street, Tucson,
2 Arizona 85701.

3 IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113 - Unauthorized
4 Communications) applies to this proceeding and shall remain in effect until the Commission's
5 Decision in this matter is final and non-appealable.

6 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend,
7 or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at
8 hearing.
