Although we will not authorize a DSIC herein, today, we are supportive of the DSIC type mechanism and therefore we will leave this Docket open to allow the parties the opportunity to enter into discussions regarding AWC's DSIC proposal and other DSIC like proposals staff may wish to introduce.

In order to allow other parties that may be interested in this issue the ability to have input, we will allow such parties the opportunity to request late intervention in this Docket for the specific and limited purpose of participating in proceedings addressing the two proposals referenced in the previous paragraph. Requests to intervene shall be filed no later than February 20, 2013.
