TRICO ELECTRIC  
COOPERATIVE INC.'S REQUEST  
FOR AN ORDER NUNC PRO  
TUNC

On January 31, 2013, the Arizona Corporation Commission ("Commission") issued Decision No. 73634 regarding Trico Electric Cooperative Inc.'s ("Trico") 2013 Renewable Energy Standard Implementation Plan ("REST Plan"). In reviewing the Decision, Trico found that the Decision currently orders its present Renewable Energy Standard Tariff to remain in effect – and does not order the Renewable Energy Standard Tariff to reflect the reduction in the REST Plan budget associated with the Commission approved modifications to the REST Plan reducing the Up-Front Incentive ("UFI") levels from 20 cents per Watt to 10 cents per Watt. Therefore, Trico requests that Decision No. 73634 be amended by replacing the current ordering paragraph on page 7, lines 18 through 21, with the following two ordering paragraphs:


- *"IT IS FURTHER ORDERED that the Trico Electric Cooperative, Inc. Voluntary Renewable Energy Standard Program Tariff, Renewable Energy Customer Self-Directed Tariff, and SunWatts Sun Farm Tariff currently on file with the Commission, remain in effect until further Order of the Commission."* and
- *"IT IS FURTHER ORDERED that the Trico Electric Cooperative, Inc. Renewable Energy Standard Tariff be modified to reflect surcharge reductions associated with a reduction in the UFI from 20 cents per Watt to 10 cents per Watt. Trico shall file the modified Renewable Energy Standard Tariff in compliance with this Decision."*
