
24 On January 31, 2013, the Arizona Corporation Commission issued Decision No.
25 73636 in the above-captioned matter. Upon reviewing the order, APS discovered that the
26 budget and customer caps identified in the Decision did not reflect the substantive
27 programs and line items approved by the Commission. Accordingly, APS requests an
28 Order nunc pro tunc to modify the Decision as follows:

Corrected Language for Ordering Paragraph No. 1 in Decision No. 73636:

IT IS THEREFORE ORDERED that a REST charge of \$0.009575/kWh, with monthly caps of \$3.83 for residential customers, \$142.25 for non-residential customers, and \$1,000 for non-residential customers with demands of 3 MW or greater, increasing by \$200 every two months until January 1, 2014, be and hereby is approved. This includes a total budget approval of \$102.6 million with \$86.1 million paid through 2013 REST

1 surcharge funds, \$10.5 million paid through production tax credits and
2 reallocations of previous years' funds, and \$6 million paid through Base
3 Rates.
