
**WRA'S RESPONSE TO JOINT
REQUEST TO MODIFY
PROCEDURAL ORDER**

1 Western Resource Advocates ("WRA") responds to the Joint Request to Modify
2 Procedural Order submitted by Arizona Public Service Company, Tucson Electric Power
3 Company and UNS Electric, Inc. as follows:

4 WRA does not object to the companies' requested modifications to the Procedural Order
5 issued on February 15, 2013. However, WRA notes that the deadline for intervention shown on
6 page 2 of the Joint Request differs from that shown on page 4. The proposed deadline on page 2
7 is April 10 and the proposed deadline for intervention on page 4 is April 15. WRA supports the
8 April 15, 2013 deadline for intervention to insure that customers receiving bill inserts at the end
9 of the billing cycle have sufficient time to intervene in the proceeding.


