14 The Utilities Division ("Staff") of the Arizona Corporation Commission ("Commission") files
 15 its response to proposed procedural schedule filed by EPCOR Water Arizona Inc., and Chaparral City
 16 Water Company (collectively "EPCOR" or "Company") and the response filed by the Residential
 17 Utility Consumer Office ("RUCO"). Staff supports the position advanced by RUCO, that the matter
 18 should be suspended because of EPCOR's intervention in the Arizona Water DSIC phase 2
 19 proceeding, Docket No. W-01445A-11-0310. However, should this matter be set for a hearing, Staff
 20 fully supports the dates proposed by RUCO. Staff opposes the dates proposed by EPCOR. As Staff
 21 had discussed with EPCOR, because of Staff's resource constraints, Staff would be unable to meet
 22 any of the dates proposed by the Company.


