

**ORDER CORRECTING

Having considered the entire record herein and being fully advised in the premises, the Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

FINDINGS OF FACT

1. On February 20, 2013, the Commission issued Decision No. 73737 in the above-captioned matters.
2. On February 25, 2013, Morenci Water and Electric Company ("MWE") filed a Request for an Order *Nunc Pro Tunc* in order to correct typographical errors in the Order. Following issuance of Decision No. 73737, MWE discovered a typographical error concerning the Base Cost of Purchased Power for the large customer class. The correct charge should be \$0.05000 per kWh. MWE also noticed a typographical error in the rate schedules for the Water Departments.
3. According to the direct testimony of the Commission's Utilities Division ("Staff"), the

1 correct Base Cost of Purchased Power for the Large Customer Class on a going-forward basis should
2 be \$0.05000 per kWh. On page 9, line 25, and page 23, line 27, of Decision No. 73737, the Base Cost
3 of Purchased Power in the proposed rate column, and as listed in the ordering section of the Decision,
4 is incorrect and should be corrected.¹

5 4. In addition, as noted by MWE, in the approved tariffs for the Water Division the word
6 “discounted” should properly be “disconnected.”

7 **CONCLUSIONS OF LAW**

8 1. MWE is a public service corporation within the meaning of Article XV of the Arizona
9 Constitution.

10 2. The Commission has jurisdiction over MWE and over the subject matter of the
11 application.

12 3. Decision No. 73737 should be corrected, *nunc pro tunc*, as discussed herein.

Page 9, line 25 in the "Proposed Rate" column, DELETE "\$0.07522" and REPLACE with "\$0.05000";

Page 23, line 27 DELETE "\$0.07522" and REPLACE with "\$0.05000";

Page 24, line 3 ½ and Page 27, line 18 DELETE "discounted" and REPLACE with "disconnected."

IT IS FURTHER ORDERED that this Decision shall become effective immediately.
