**STAFF'S REQUEST
FOR AN EXTENSION OF TIME**

On January 10, 2013, the Administrative Law Judge assigned to these consolidated matters issued a Procedural Order establishing dates to govern this proceeding. Pursuant to that order, the Utilities Division ("Staff") of the Arizona Corporation Commission ("Commission") is required to file its consolidated Staff Report no later than March 1, 2013 and any objections to that report be filed by the other parties no later than March 15, 2013.

Staff respectfully requests a seven (7) day extension to file its consolidated Staff Report and a corresponding extension for the other parties to file any objections to that report. Although Staff has been diligently processing the consolidated applications in this proceeding as expeditiously as possible, the severely constrained resources and existing workload of Staff has necessitated the instant request. Staff does not believe this request will impact the hearing dates, currently scheduled to begin on April 2, 2013. Accordingly, Staff respectfully requests that the current filing dates be modified to allow the consolidated Staff Report to be filed no later than March 8, 2013 and any objections to that report to be filed no later than March 22, 2013.
