PROCEDURAL ORDER

BY THE COMMISSION:

By Procedural Order dated July 13, 2012, procedural guidelines for the hearing in this matter were set, including the dates for the hearing and a form of public notice. The schedule was modified slightly by Procedural Order dated August 17, 2012.

On February 26, 2013, Rio Rico Utilities, Inc. ("RRUI" or "Company") filed an Unopposed Motion to Extend the Deadline to File Rejoinder Testimony. RRUI requests to extend the deadline for filing rejoinder from March 5, 2013, to March 8, 2013, to allow additional time for discovery and complete rejoinder. RRUI reports that counsel for the Commission's Utilities Division and the intervenors do not object.

The hearing in this matter is set to commence on March 27, 2013. There is ample time for parties to review the rejoinder testimony under the proposed extension prior to the hearing.

IT IS THEREFORE ORDERED that the procedural schedule set in the July 13, 2012 Procedural Order is modified to provide that **rejoinder testimony is due by March 8, 2013.**


