RE: WIMACTEL, INC. – APPLICATION FOR APPROVAL TO PROVIDE CUSTOMER OWNED PAY TELEPHONE SERVICES (DOCKET NO. T-20766A-12-0396)

On September 6, 2012, WiMacTel, Inc. (“WiMacTel” or “Company”) filed an Application to obtain a Certificate of Convenience and Necessity (“CC&N”) to provide customer owned pay telecommunications (“COPT”) services. On November 1, 2012, WiMacTel filed one replacement proposed tariff page. The proposed rates, charges, terms and conditions for COPT service are contained in WiMacTel’s proposed Generic tariff, COPT Tariff No. 1.

The Company indicated in its Application that it will provide service in accordance to the rates, charges, terms and conditions contained within the COPT Generic Tariff. WiMacTel has also indicated in its Application that it does not have any COPTs at this time.

A customer information placard was provided with the Application. Staff has reviewed the Company’s customer information placard and has concluded that it meets the terms of the COPT Generic Tariff.

The Consumer Services Section of the Utilities Division reports no complaints, opinions, or inquiries filed against WiMacTel within Arizona through September 17, 2012. WiMacTel is also in good standing with the Corporations Division of this Commission.

Staff believes that certain benefits in the form of increased pay telephone availability will accrue to the public and that the issuance of a Certificate in is the public interest.

Staff recommends approval of the Application without a hearing pursuant to A.R.S § 40-282.
