Rio Virgin Telephone Company (Company) respectfully files the attached notice pursuant to *Wireline Broadband Order* of the intent of the Company to discontinue its Wireline Broadband Internet Access Service (WBIAS) Offering under NECA's Tariff F.C.C No.5 effective July 1, 2013. Upon discontinuance of the tariffed offerings, the Company will provide WBIAS on a common-carriage non-tariff basis.
