**PROCEDURAL ORDER**  
**MODIFYING FILING DEADLINE**

**BY THE COMMISSION:**

On July 6, 2012, Far West Water & Sewer, Inc. ("Far West") filed the above-captioned rate application with the Arizona Corporation Commission ("Commission").

On August 30, 2012, a Rate Case Procedural Order was issued scheduling a hearing on the application to commence on April 22, 2013, and setting associated procedural deadlines.

Intervention has been granted to the Residential Utility Consumer Office ("RUCO"), Spartan Homes & Construction, Inc., Robert C. Gilkey, Barbara S. Gilkey, Robert Rist, Rodney Taylor, Kim Taylor, Seth Davis, Barbara Davis, and Jerry S. Durden.

On March 6, 2013, Far West filed a Motion to Extend Filing Deadline: Rate Design Testimony. In its Motion, Far West stated that Staff was provided two extra days to file its rate-design testimony and Far West also needs two additional business days to respond to Staff's rate-design testimony. Far West indicated that Staff and RUCO do not oppose the extension request.

**IT IS THEREFORE ORDERED that Far West's request for an extension of time to file its rate design rebuttal testimony is hereby granted.**
