**JOINT REQUEST FOR
EXTENSION**

Montezuma Rimrock Water Company and Commission Staff hereby file this joint request for an extension of the hearing date scheduled for May 3, 2013 and the associated filing dates for testimony. Based upon discussions with Staff, the Company intends to make amended filings in the rate case relating to financing approvals for the lease agreements, surcharge mechanisms and certain storage tanks. The Company also intends to update certain filings in the rate case. Because of those amended filings, Commission Staff and the Company believe the parties would be better served by extending the hearing dates and testimony dates until after those amended filings are made to allow the parties to address those filings in direct testimony. The Company seeks resolution of the rate case as quickly as possible, but recognizes that additional filings may clarify certain procedural and other issues in the case. The Company and Commission Staff do not believe that those filings can be made prior to the April 5 deadline for testimony and prior to the May 3 hearing date such that the parties can adequately consider and address those filings in the testimony due on April 5 and April 19, or the hearing on May 3.


The Company and Commission Staff hereby request that the hearing date and testimony filing dates be extended by 30-45 days, subject to availability on the Administrative Law Judge's calendar. Commission Staff has consulted intervenor Mr. Dougherty on this issue and he opposes such extension.


