**RUCO'S MOTION TO CONTINUE TIME TO FILE
SURREBUTTAL TESTIMONY ON RATE DESIGN**

The Residential Utility Consumer Office ("RUCO") hereby files this motion to continue the time to file surrebuttal testimony on rate design. One of RUCO's analysts has been hospitalized unexpectedly for the last week. We do not anticipate him returning to work before Monday, March 25, 2013.

Surrebuttal Testimony is due on March 29, 2013. RUCO's analyst is testifying on both Required Revenue and Rate Design. RUCO will file required revenue surrebuttal testimony on time, but will need a short continuance until April 3, 2013 to file rate design surrebuttal testimony. All other testimony from all other RUCO witnesses will be filed, timely.

The Company and Spartan Homes have no objection. Staff and Intervenors Gilkey and Rist have no objection, as long as they are afforded the same extension. RUCO has


