PROCEDURAL ORDER

BY THE COMMISSION:

By Procedural Order dated March 11, 2013, a procedural schedule was established for filing briefs in the Second Phase of the above-captioned matter.

On March 21, 2013, Columbus Electric Cooperative, Inc. ("Columbus") filed a Request to Modify Procedural Order seeking to extend the dates for filing briefs. Columbus stated that the Arizona Corporation Commission Utilities Division ("Staff") does not object to the request. Columbus proposed the following:

Extend Columbus's Initial Brief deadline from March 25, 2013, to April 8, 2013;

Extend Staff's Brief from April 29, 2013, to May 13, 2013;

Extend Columbus' Reply Brief from May 13, 2013, to May 28, 2013.

No party will be prejudiced by the requested extension.

IT IS THEREFORE ORDERED that the procedural schedule in this matter is modified as follows:

CEC shall file an Initial Brief on its request for Declaratory Order by **April 8, 2013**.

Staff shall file its Brief in this matter by **April 29, 2013**.

CEC shall file a Reply Brief (optional), by **May 13, 2013**.¹


IT IS FURTHER ORDERED that either party may request oral argument in this matter, and are put on notice that the Administrative Law Judge may request Oral Argument or additional


