At the Procedural Conference held on April 2, 2013, the Administrative Law Judge assigned to these matters asked the Utilities Division ("Staff") of the Arizona Corporation Commission ("Commission") whether Staff's recommended rates for Doyle Thompson in the Staff Report filed on March 8, 2013 covered the estimated \$50,000 cost for a permit from the Arizona Department of Environmental Quality ("ADEQ"). Responsive to that question, Staff hereby provides notice of filing the following response by Staff Witness Crystal Brown:


Staff's recommended rates for Doyle Thompson did not include the \$50,000 permitting cost from ADEQ because that is a capital cost. Capital costs are included in rate base once expended and determined to be used and useful.
