REQUEST FOR AN ORDER NUNC PRO TUNC -IN THE MATTER OF THE APPLICATION OF TRICO ELECTRIC COOPERATIVE, INC. FOR APPROVAL OF ITS 2013 RENEWABLE ENERGY STANDARD AND TARIFF IMPLEMENTATION PLAN.

BY THE COMMISSION:

FINDINGS OF FACT

1. Trico Electric Cooperative, Inc. ("Trico") is certificated to provide electricity as a public service corporation in the State of Arizona.
 2. On January 31, 2013, the Commission issued Decision No. 73634 which granted Trico approval of its 2013 Renewable Energy Standard and Tariff ("REST") Plan. Decision No. 73634 reduced the residential up-front incentive ("UFI") level for photovoltaic systems up to 10 kW in size to \$0.10 per watt. Based on the reduced UFI amount, the residential UFI budget was reduced to \$163,445 for photovoltaic systems and the total REST budget was reduced to \$1,493,088. On February 13, 2013, Trico filed a request for an Order Nunc Pro Tunc which would specifically approve adjusted per kWh surcharges that correspond to the reduced budgets approved in Decision No. 73634.

3. Based on the reduced REST budget approved in Decision No. 73634, Trico has provided Staff with adjusted per kWh surcharge amounts that correspond to the approved \$1,493,088 total REST budget. The table below shows the adjusted per kWh surcharges compared to the per kWh surcharges from the original budget.

Customer Class	Original Surcharges	Adjusted Surcharges
Residential	\$0.008065	\$0.005550
Non-Residential	\$0.008065	\$0.005550
Non-Residential >3MW	\$0.008065	\$0.005550
Governmental & Agricultural	\$0.001411	\$0.000971

4. Because Decision No. 73634 was issued without the adjusted surcharges specified above, Staff believes that an Order Nunc Pro Tunc should be issued to reflect all of the changes impacted by the reduced budgets that were approved. Therefore, Staff has recommended that an Order Nunc Pro Tunc should be issued for Decision No. 73634 to include the following:

(A) Page 7 lines 18 through 21 should be revised to read:

“IT IS FURTHER ORDERED that the Trico Electric Cooperative, Inc. Voluntary Renewable Energy Standard Program Tariff, Renewable Energy Customer Self-Directed Tariff, and SunWatts Sun Farm Tariff currently on file with the Commission, remain in effect until further Order of the Commission.”

(B) Page 7 Line 22 should include the new ordering paragraphs as follows:

“IT IS FURTHER ORDERED that the per kWh surcharges shall be set at \$0.000971 for government and agricultural customers and \$0.005550 for the remaining customer classes.”

“IT IS FURTHER ORDERED that Trico Electric Cooperative shall file, as a compliance item, a revised Renewable Energy Standard Tariff that contains the above adjusted per kWh surcharges within 15 days of the date of this Decision.”

CONCLUSIONS OF LAW

1. Trico Electric Cooperative, Inc. is an Arizona public service corporation within the meaning of Article XV, Section 2, of the Arizona Constitution.


(B) Page 7 Line 22 should include the new ordering paragraphs as follows:
 "IT IS FURTHER ORDERED that the per kWh surcharges shall be set at \$0.000971 for government and agricultural customers and \$0.005550 for the remaining customer classes."
 "IT IS FURTHER ORDERED that Trico Electric Cooperative shall file, as a compliance item, a revised Renewable Energy Standard Tariff that contains the above adjusted per kWh surcharges within 15 days of the date of this Decision."

IT IS FURTHER ORDERED that all other aspects of Decision No. 73634 shall remain in effect.

IT IS FURTHER ORDERED that this Order shall become effective immediately.
