BY THE COMMISSION:

On January 31, 2013, the Commission entered Decision No.73637, corrected *Nunc Pro Tunc* by Decision No. 73767. Decision No. 73637 sets forth certain matters describing proceedings related to "Track and Record" for further Commission consideration. Pursuant to A.R.S. § 40-252, with notice and opportunity to be heard on March 12, 2013, the Commission hereby voted to modify Decision No. 73637 to eliminate from further consideration in the "Track

1 and Record” proceedings any proposal that would require the exclusion of retail sales to the
2 utilities’ largest customers (3MW or greater in demand) from their overall retail sales calculation
3 under the Renewable Energy Standard and Tariff Rule R14-2-1804. The Commission further
4 directed the Hearing Division to modify its procedural order(s) to conform to this Order.

5 THEREFORE, IT IS ORDERED that Decision No. 73637, corrected *Nunc Pro Tunc* by
6 Decision No. 73767, is modified to eliminate from further consideration in the “Track and Record”
7 proceedings any proposal that would require the exclusion of retail sales to the utilities’ largest
8 customers (3MW or greater in demand) from their overall retail sales calculation under the
9 Renewable Energy Standard and Tariff Rule R14-2-1804.


