**STAFF'S MOTION FOR EXTENSION OF
TIME TO FILE SURREBUTTAL
TESTIMONY**

On September 7, 2012, the Hearing Division issued its Rate Case Procedural Order ("Order") which set the schedule for the filing of testimony, the Pre-Hearing Conference and the Hearing. Pursuant to that Order, Staff's Surrebuttal Testimony is due Monday, April 15, 2013. The Order also set the Hearing in this matter to commence on May 7, 2013 at 10:00 a.m. at the Arizona Corporation Commission's Tucson office, Room 222, 400 West Congress, Tucson, Arizona, 85701.

Based on the testimony of the Company and Staff filed to date, the parties hereto deem it wise to entertain the possibility of settlement with an eye toward resolving most, if not all, of the outstanding issues in this matter. On April 10, 2013, Staff filed Staff's Notice of Settlement Discussions wherein notice was given that the parties to this docket may engage in settlement negotiations beginning on or after Tuesday, April 16, 2013. Given the pending settlement negotiations, Staff hereby requests a one-week extension, or until Monday, April 22, 2013, to file its Surrebuttal Testimony. The Company has been notified of and has no objection to Staff's request.


