PROCEDURAL ORDER

BY THE COMMISSION:

By Procedural Order dated September 7, 2012, the hearing in the above-captioned matter was set for May 7, 2013, and other procedural deadlines were established. Under that directive, the deadline for the Arizona Corporation Commission ("Commission") Utilities Division ("Staff") surrebuttal testimony was set as April 15, 2013.

On April 11, 2013, Staff filed a Motion for Extension of Time to File Surrebuttal Testimony, until April 22, 2013. Staff repots that on April 10, 2013, it filed its Notice of Settlement Discussions indicating that settlement discussions would commence on or after April 16, 2013. Given the pending settlement discussions, Staff requested a one-week extension. Staff states that the Applicant has no objection to the request.

Staff's request is reasonable under the circumstances.

IT IS THEREFORE ORDERED that Staff's request for an extension of the deadline to file its surrebuttal testimony until April 22, 2013, is granted.




