**STAFF'S SECOND MOTION FOR
EXTENSION OF TIME TO FILE
SURREBUTTAL TESTIMONY**


On September 7, 2012, the Hearing Division issued its Rate Case Procedural Order ("Order") which set the schedule for the filing of testimony, the Pre-Hearing Conference and the Hearing. Pursuant to that Order, Staff's Surrebuttal Testimony is due Monday, April 15, 2013. The Order also set the Hearing in this matter to commence on May 7, 2013 at 10:00 a.m. at the Arizona Corporation Commission's Tucson office, Room 222, 400 West Congress, Tucson, Arizona, 85701.

On April 11, 2013, Staff filed a Motion for Extension of Time to File Surrebuttal Testimony ("Motion") whereby Staff requested a one week extension, or until April 22, 2013, to file its Surrebuttal Testimony based on proposed settlement negotiations. On April 17, 2013, Staff's Motion was granted.

Settlement negotiations subsequently commenced and are ongoing. Based on the significant progress and favorable disposition of these discussions which have continued through the date hereof, Staff hereby requests a second extension of two days, or until Wednesday, April 24, 2013, to file its Surrebuttal Testimony. The Company has been notified of and has no objection to Staff's second request. Moreover, it should be noted that, in the event Staff's second motion is granted and settlement is ultimately not reached as presently anticipated, the Company may request comparable additional time to file its Rejoinder Testimony to which Staff would have no objection.

1 Based on the foregoing, Staff requests that it be provided a second, two-day extension until
2 Wednesday, April 24, 2013, to file its Surrebuttal Testimony.
