**STAFF'S REQUEST FOR A
MODIFICATION OF THE
PROCEDURAL SCHEDULE**


11 Staff of the Arizona Corporation Commission (“Staff”) hereby requests an extension of time
12 to file direct testimony and a modification of the procedural schedule in this case. The deadline for
13 Staff’s direct testimony (excluding rate design) is now May 6, 2013. Because of the complexity of
14 the issues raised in this case, Staff requires a 60-day extension of time until July 8, 2013 to file its
15 direct testimony. Staff also requests that the remaining dates in the procedural schedule be extended
16 by the same 60-day period. Accordingly, the existing procedural schedule would be revised as
17 follows:

18	Staff/Intervenor Direct Testimony (issues other than rate design)	July 8, 2013
19	Staff/Intervenor Direct Testimony (rate design issues)	July 15, 2013
20	Settlement Agreement (if any)	August 12, 2013
21	Global Rebuttal Testimony (if no Settlement)	August 12, 2013
22	Testimony in Support/Opposition to Settlement	August 21, 2013
23	Staff/Intervenor Surrebuttal Testimony (if no Settlement)	August 28, 2013
24	Responsive Testimony regarding Settlement	August 30, 2013
25	Global Rejoinder Testimony (if no Settlement)	September 3, 2013
26	Pre-Hearing Conference	September 4, 2013
27	Hearing	September 5, 2013

1 Staff has conferred with the Company regarding the extension of time and the Company does
2 not object. In addition, the Company has agreed to a 60-day extension of the time clock for
3 processing this case. Staff has also conferred with RUCO, New World Properties, the City of
4 Maricopa, and the Maricopa Area Homeowners Association¹ and these parties have also indicated
5 that they do not oppose the extension requested herein.

6 WHEREFORE, Staff respectfully requests that the Hearing Division modify the procedural
7 schedule as discussed above.
