PROCEDURAL ORDER
(Continues Hearing)

BY THE COMMISSION:

On January 15, 2013, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing ("Notice") against TV Products, LLC ("TVP") and Stephen Christopher Donovan (collectively "Respondents"), in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of membership interests in TVP.

The Respondents were duly served with copies of the Notice.

On February 19, 2013, Respondents filed an Answer to the Notice in this matter, and their Answer will be treated as their request for a hearing pursuant to A.R.S §44-1972 and A.A.C. R14-4-306.

On February 28, 2013, by Procedural Order, a pre-hearing conference was scheduled on March 14, 2013.

On March 14, 2013, at the pre-hearing conference, Respondents and the Division appeared through counsel. Counsel for Respondents and the Division's attorney indicated that a hearing should be scheduled after August 1st to last for at least two days.

On March 18, 2013, a hearing was scheduled on August 6, 2013.

1 Due to a scheduling conflict, the proceeding will have to be continued.

2 IT IS THEREFORE ORDERED the **hearing** scheduled on **August 6, 2013, shall be**
3 **continued to August 14, 2013, at 10:00 a.m.**, at the Commission's offices, 1200 West Washington
4 Street, Hearing Room No. 2, Phoenix, Arizona.

5 IT IS FURTHER ORDERED that **the parties shall reserve August 15 and 16, 2013, for**
6 **additional days of hearing**, if necessary.

7 IT IS FURTHER ORDERED that **the Division and Respondents shall exchange copies of**
8 **their Witness Lists and copies of their Exhibits by June 21, 2013**, with courtesy copies provided
9 to the presiding Administrative Law Judge, as previously ordered.

10 IT IS FURTHER ORDERED that if the parties reach a settlement on the issues raised in the
11 Notice prior to the hearing, the Division shall file a Motion to Vacate the hearing.

12 IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113-Unauthorized
13 Communications) is in effect and shall remain in effect until the Commission's Decision in this
14 matter is final and non-appealable.

15 IT IS FURTHER ORDERED that all parties must comply with Rules 31 and 38 of the Rules
16 of the Arizona Supreme Court and A.R.S. § 40-243 with respect to the practice of law and admission
17 *pro hac vice*.

18 IT IS FURTHER ORDERED that withdrawal or representation must be made in compliance
19 with A.A.C. R14-3-104(E) and Rule 1.16 of the Rules of Professional Conduct (under Rule 42 of the
20 Rules of the Arizona Supreme Court). Representation before the Commission includes appearances
21 at all hearings and procedural conferences, as well as all Open Meetings for which the matter is
22 scheduled for discussion, unless counsel has previously been granted permission to withdraw by the
23 Administrative Law Judge or the Commission.


