PROCEDURAL ORDER

BY THE COMMISSION:

On April 18, 2013, the Arizona Corporation Commission Utilities Division ("Staff") filed a Second Motion for Extension of Time to File Surrebuttal Testimony, from Monday April 22, 2013, until Wednesday April 24, 2013. Staff reports that settlement negotiations commenced and are ongoing and that based on significant progress in those discussions, Staff requests additional time to file its surrebuttal testimony. Staff further reports that Vail Water Company (the "Company") does not object to the extension, and that Staff would not object if the Company requests comparable additional time to file Rejoinder Testimony if needed.

Given the circumstances, Staff's request is reasonable.¹

IT IS THEREFORE ORDERED that Staff's request for an **extension of the deadline** to file its **surrebuttal testimony** until **April 24, 2013**, is granted.


