

tervention in the Commis-
sion's proceedings on the
application shall be permit-
ted to any person entitled
by law to intervene and hav-
ing a direct substantial in-
terest in this matter. Per-
sons desiring to intervene

which must be served upon
Applicants' counsel and
which, at a minimum shall
contain the following infor-

statement of the proposed
intervenor's interest in the
proceeding; (3) Whether the
proposed intervenor desires
a formal evidentiary hearing
on the application and the
reasons for such a hearing;
(4) A statement certifying
that a copy of the Motion to
intervene has been mailed
to Applicants' counsel. In-
tervention shall be in ac-
cordance with A.A.C. R14-3-
105, except that all Motions
to Intervene must be filed
on, or before, the 15th day
after this notice.


