PROCEDURAL ORDER

...

1 **BY THE COMMISSION:**

2 On March 21, 2013, the procedural schedule for this matter was modified to require, *inter*
3 *alia*, the filing of Direct Testimony and Exhibits by May 23, 2013, and the filing of Responsive
4 Testimony and Exhibits by June 6, 2013. Additionally, the Pre-Hearing for this matter was scheduled
5 for June 14, 2013, and the Hearing was scheduled to commence on June 20, 2013, and to continue, as
6 necessary, on June 21 and June 24-26, 2013.

7 On May 21, 2013, the Commission's Utilities Division ("Staff") filed Staff's Request for
8 Filing Extension ("Request"), stating that due to Staff workload and resource constraints, Staff
9 requests a one-day extension so that it may file its Staff Report on May 24, 2013. Staff stated that
10 counsel for Montezuma Rimrock Water Company, LLC ("Montezuma") expressed no objection to
11 the request provided that Montezuma also receives a one-day extension. Staff also stated that a
12 message had been left for John Dougherty, but that Staff had not yet received a response at the time
13 of filing its Request.

14 Although Mr. Dougherty's position regarding Staff's Request is not known, it appears that
15 Staff requires additional time to prepare and file its Direct Testimony and Exhibits. As Staff has
16 requested only a very brief extension of time, and no party's interests would be best served by
17 requiring Staff to file Direct Testimony and Exhibits that are not yet complete or that have not yet
18 been adequately scrutinized, it is reasonable and appropriate to grant Staff's Request and, likewise, to
19 extend the filing deadline for all parties' Direct Testimony and Exhibits.

20 **IT IS THEREFORE ORDERED** that the filing deadline for **Direct Testimony and Exhibits**
21 **is hereby extended to May 24, 2013.**
