However, MEC's participation is necessary and appropriate because only MEC is in a position to ensure the record fully explains the impacts on its system and operations.

MEC or its legal counsel has discussed its intervention with all parties (AEPCO, Sulphur Spring Electric Cooperative, Inc., Trico Electric Cooperative and Staff) and no party opposes MEC's intervention.
