PROCEDURAL ORDER

BY THE COMMISSION:

On August 3, 2012, Southwest Transmission Cooperative, Inc. ("SWTC") filed with the Arizona Corporation Commission ("Commission") an application for a rate decrease.

Trico Electric Cooperative, Inc. ("Trico") and Sulphur Springs Valley Electric Cooperative ("SSVEC") have been granted intervention.

On May 23, 2013, Mohave Electric Cooperative, Incorporated ("Mohave") filed a Motion to Intervene. Mohave requests that it be granted intervention past the intervention deadline specified in the Rate Case Procedural Order. Mohave states that its participation will not unduly broaden the issues to be presented because Mohave adopts the position of SWTC, and that Mohave's participation is necessary and appropriate. Counsel for Mohave avers that it has discussed its intervention in this matter with all parties, and no party opposes Mohave's intervention.

Accordingly, Mohave should be granted intervention.


