On May 22, 2013, Utilities Division Staff ("Staff") filed its Closing Brief in this docket. Prior to that date, in a May 13, 2013, Procedural Order, the administrative law judge granted Staff's request to extend the deadline for filing its Closing Brief to May 22, 2013, and the deadline for filing a responsive pleading by Johnson Utilities, L.L.C.
