The accounting services I have provided for Montezuma Rimrock Water Co. (MRW Co) are as follows;

- 1.) Prepare the financial schedules as required in the year end reports for the ACC utilities division.
- 2.) Prepare the financial schedules as required in the year end reports for AZ Dept of Revenue
- 3.) Prepare federal payroll tax returns. (I have not prepared payroll tax returns since 2010, since no wages were paid since 2010).
- 4.) other non-recurring services I have performed are financial schedules in response to questions from ACC in response to rate increase applications that were made by MRW Co.

I do *not* make entries to record any of the checking account activity or any other aspects of on going financial business activities of the MRW Co. Essentially, I do not prepare the "books". After all the business activities are recorded on the accounting records for the year by Patricia Olsen, I then get a copy of the accounting records that I use to prepare the above listed reports.

I have also responded to all of the numerous data requests from Mr Dougherty over the past 2 years that have been a burden on my time that I have not yet been compensated for as of this time.

The MRW Co. owes me \$2,243 for approximately 39 hours for my past services dating back to August, 2012. The last payment I received was the amount of \$200 on 2-27-2013, which was to complete payment for an invoice dated 5/2/2012.

I had a 20 year corporate accounting career in the past, but accounting is currently not my main business activity. My main business activity is a complimentary healing business, Foot Reflexology, that I operate as a sole proprietor, one person business, in Sedona, Arizona. I need to be at my office in order to be in business. 50% of my business comes from tourists to Sedona. I need to be in my office each day. Generally, when a tourist calls, they want my services as soon as possible. My presence at the hearing referred to in the subpoena will put a financial burden on my business activities.


I have no other relevant information that I can provide, therefore I do not believe I need to be present at the hearing, since it will cause me to be away from my business.


