On June 13, 2013, Respondents Christopher Dean Dedmon, Kimberly Dedmon and SDC Montana Consulting, LLC (collectively, "SDC"), through their attorneys, filed a Motion to Compel Compliance with the Administrative Subpoena Duces Tecum issued on February 19, 2013 by the Commission to Clear Energy Systems, Inc. ("Subpoena Duces Tecum") (the "Motion to Compel"). In response to the Motion to Compel, the Securities Division respectfully (1) states that it takes no position as to the factual allegations of noncompliance on the part of Clear Energy Systems, Inc. contained in the Motion to Compel; and (2) acknowledges that the Administrative Law Judge, on behalf of the Commission, has the authority to enforce compliance with the Subpoena Duces Tecum, which authority includes the issuance of a civil contempt order and the imposition of fines.
