REQUEST TO EXTEND DEADLINE
FOR FILING RESPONSE TO STAFF'S
CLOSING BRIEF

In a June 11, 2013, Procedural Order, the administrative law judge granted the request of Johnson Utilities, L.L.C. ("Johnson Utilities" or the "Company") to extend the deadline for filing its response to the Closing Brief filed by Utilities Division Staff ("Staff") on May 22, 2013. Johnson Utilities and Staff met on June 14, 2013, in an effort to clarify and narrow the disagreements between the parties regarding Staff's recommendations as listed in Staff's Closing Brief. The meeting was productive and the parties would like some additional time for further discussions and to gather some additional information. Thus, Johnson Utilities requests that the current deadline for filing its response to Staff's Closing Brief be extended for two weeks through and including Monday, July 1, 2013. The Company further requests that the deadline for Staff's reply to the response be extended through and including Monday, July 15, 2013. Counsel for Staff has authorized counsel undersigned to represent that Staff supports this request.


