**STAFF'S NOTICE OF FILING
SUPPLEMENT TO CLOSING BRIEF**

Subsequent to the filing of Staff's Notice of Filing Closing Brief on May 22, 2013, new information has come to Staff's attention. Staff submits this supplement to its Brief for the purpose of making the Administrative Law Judge aware of the same, but the new information does not change Staff's position on the issues in this matter.

In its Closing Brief, Staff argued that Johnson Utilities, LLC ("Johnson") had not established that two Notices of Violation ("NOVs") issued by the Arizona Department of Environmental Quality ("ADEQ") in October and November of 2012 had been closed. Staff has now learned that, in fact, ADEQ has closed these NOVs and that the correspondence of April 12, 2013, docketed by Johnson as a late filed exhibit on April 19, 2013, was intended to so reflect. However, Staff has also learned that two additional NOVs were issued to Johnson on May 31, 2013, and were docketed in Docket Nos. WS-02987A-99-0583, WS-02987A-00-0618; WS-02987A-00-0774 and WS-02987A-00-0784. Based upon the fact that Johnson remains out of compliance with ADEQ, these facts do not change Staff's position in this matter.
