PROCEDURAL ORDER

BY THE COMMISSION:

An evidentiary hearing in this matter is scheduled to commence on June 20, 2013.

1 On June 14, 2013, a pre-hearing conference in this matter was held, with Montezuma  
2 Rimrock Water Company, LLC ("Montezuma") and the Commission's Utilities Division ("Staff")  
3 appearing through counsel and John Dougherty appearing pro se. At the pre-hearing conference, it  
4 was determined, *inter alia*, that Monday, June 24, 2013, would be the date certain to receive  
5 testimony from several witnesses subpoenaed by Mr. Dougherty.


6 On June 18, 2013, Mr. Dougherty filed a Motion to Reschedule Witness Appearances  
7 ("Motion") stating that two of the subpoenaed witnesses, John Torbenson and Robin Richards, will  
8 be out of town and unavailable to testify on June 24, 2013. The Motion states that Mr. Torbenson  
9 and Ms. Richards are available at 9:00 a.m. on Wednesday, June 26, 2013, and requests that they be  
10 scheduled to appear as witnesses on that date. The Motion further states that counsel for Montezuma  
11 and Staff have no objection to having Mr. Torbenson and Ms. Richards testify on June 26, 2013.

12 As the other parties to this matter do not object to having Mr. Torbenson and Ms. Richards  
13 testify on June 26, 2013, Mr. Dougherty's Motion should be granted.

14 IT IS THEREFORE ORDERED that Mr. Dougherty's **Motion** to Reschedule Witness  
15 Appearances is hereby **granted**, and that **John Torbenson and Robin Richards** shall testify on  
16 Wednesday, **June 26, 2013**.

17 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend,  
18 or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at  
19 hearing.
