CORRECTION TO RATE CASE
PROCEDURAL ORDER

BY THE COMMISSION:

On April 26, 2013, Chaparral City Water Company filed the above-captioned rate application with the Arizona Corporation Commission.

On June 17, 2013, a Rate Case Procedural Order was issued setting a hearing on the application to commence on February 17, 2014, and setting associated procedural deadlines.

Because February 17, 2014 is a State holiday, it is necessary to move the commencement of the hearing to February 18, 2014. The required notice included in the Rate Case Procedural Order should likewise be modified to reflect February 18, 2014, as the date the hearing will commence.

IT IS THEREFORE ORDERED that the **hearing** in the above-captioned matter shall commence on **February 18, 2014**, or as soon thereafter as is practicable, at the Commission's offices, 1200 West Washington Street, **Hearing Room No. 1**, Phoenix, Arizona 85007.

IT IS FURTHER ORDERED that the required notice set forth in the Rate Case Procedural Order shall be modified to reflect February 18, 2014, as the date the hearing will commence.

IT IS FURTHER ORDERED that all other dates, procedural deadlines, and requirements included in the Rate Case Procedural Order shall remain in place.


