BY THE COMMISSION:

FINDINGS OF FACT

1. Tucson Electric Power Company ("TEP") is certificated to provide electric service as a public service corporation in the State of Arizona.
2. Commission Decision No. 70628 (December 1, 2008) approved the creation of the Purchased Power and Fuel Adjustment Clause ("PPFAC") through which TEP recovers or refunds its purchased power and fuel expenses that differ from the amount being recovered in TEP's base rates. Decision No. 70628 provides for TEP to file the PPFAC rate for the upcoming year by October 31 of each year and an update to the filing by February 1 of the next year. The new PPFAC rate goes into effect on April 1, but only after Commission approval. The current PPFAC rate is \$0.007696 per kWh.

IT IS FURTHER ORDERED that this Order shall become effective immediately.




