

REQUEST FOR RETROACTIVE
EXTENSION OF DEADLINE FOR
FILING RESPONSE TO STAFF'S
CLOSING BRIEF

14 In a June 19, 2013, Procedural Order, the administrative law judge granted the request of
15 Johnson Utilities, L.L.C. ("Johnson Utilities" or the "Company") to extend the deadline for
16 filing its response to the Closing Brief filed by Utilities Division Staff ("Staff") to July 1, 2013.
17 Counsel for Johnson Utilities failed to calendar the new deadline and was out of state on July 1,
18 2013, when the response was due. As a result, counsel undersigned is requesting a retroactive
19 extension of the deadline to Monday, July 8, 2013, to file the response. Counsel for Utilities
20 Division Staff does not oppose the extension of the deadline provided that Staff receives an
21 extension of the deadline for filing its reply, which is currently due on July 15, 2013. Due to
22 existing schedule conflicts, Staff requests that its reply be due on August 7, 2013. Thus,
23 Johnson Utilities requests that the Administrative Law Judge ("ALJ") retroactively extend the
24 deadline for filing the Company's response to the Staff Closing Brief to Monday, July 8, 2013,
25 and that the ALJ extend the deadline for filing Staff's reply to August 7, 2013. Counsel
26 undersigned apologizes for any inconvenience caused by this request.
