**TRICO ELECTRIC COOPERATIVE  
INC.'S REQUEST FOR AN ORDER  
NUNC PRO TUNC**

On June 27, 2013, the Arizona Corporation Commission ("Commission") issued Decision No. 73929 regarding Trico Electric Cooperative Inc.'s ("Trico") 2013-2014 Electric Energy Efficiency Implementation Plan ("EE Plan"). The proposed order underlying Decision No. 73929 was originally scheduled to be heard at the April 9, 2013 Open Meeting. The matter was continued to the June 11, 2013 Open Meeting, however. In reviewing the Decision, Trico found that the Decision ordered that the Demand-Side Management ("DSM") Surcharge still become effective in May of 2013. No Staff amendment was submitted to update the effective date for the DSM Surcharge to reflect when the matter was heard and voted on, although arguably the date change was simply a conforming change.

Trico understands that Staff does not object to changing the effective date. Therefore, in order to clarify the Decision and update the effective date, Trico requests that Decision No. 73929 be amended by replacing the current ordering paragraph on page 27, lines 3 through 4, with the following ordering paragraph:

- *"IT IS FURTHER ORDERED that the DSM Surcharge shall become effective September 1, 2013."*


Trico believes that these are conforming changes and requests that the Commission enter an Order Nunc Pro Tunc to correct the decision.
