MOTION TO INTERVENE**

Pursuant to A.A.C. R14-3-105, the Town of Queen Creek ("Town") moves to intervene in the above-captioned docket in support of the Application filed by H2O, Inc. ("H2O"), and states:

1. The Town has an interest in this proceeding as it has agreed to purchase the water utility assets of H2O. Under the parties' agreement, H2O is required to obtain an order from the Arizona Corporation Commission ("Commission") approving the sale of its assets and operations to the Town and the conditional cancellation and extinguishment of its existing Certificate of Convenience and Necessity. The Town seeks to intervene solely for purposes of supporting the Application filed by H2O and to provide the Commission with assurances as to its ability and intent to provide potable water service to H2O's customers as part of an integrated Town water system.

2. The Town respectfully requests that the Commission grant its motion to intervene in this matter. The Town is informed that H2O does not contest the Town's intervention in this docket.


