**MOTION FOR EXTENSION OF  
TIME TO FILE EXCEPTIONS**

17 IN THE MATTER OF THE  
18 APPLICATION OF CLEAR SPRINGS  
19 UTILITY COMPANY, INC., FOR  
20 AUTHORITY TO INCUR LONG-TERM  
21 DEBT

22 Clear Springs Utility Co., Inc. ("Company"), hereby files this Motion for  
23 Extension of Time to File Exceptions to the Recommended Opinion and Order docketed  
24 on July 2, 2013 ("ROO"). For the reasons explained below, the Company requests an  
25 order allowing parties to file exceptions to the ROO on or before August 1, 2013.

27 Currently, the exceptions are due on July 11, 2013 in order to give the parties and  
28 the Commissioners time to review the exceptions before the Open Meeting scheduled for

1 July 17, 2013. However, the matter has been rescheduled to be heard at the Open  
2 Meeting occurring on August 13 and 14, 2013. Extending the deadline for filing  
3 exceptions as requested will leave the Commissioners and other parties seven business  
4 days to review and consider the comments, which is four more days than available under  
5 the current schedule.

8 The Company intends to comment on several issues raised in the ROO. The ROO  
9 was received on July 3, 2013, and due to the Independence Day holiday, the Company  
10 had only five business days thereafter to file such comments. The Company needs more  
11 time to adequately prepare its comments.


