**COMPLIANCE FILING**


Pursuant to Decision No. 73672, this Compliance Filing notifies the Commission that the Onvoy *Pro Forma* Transaction was completed. As a result, Onvoy provides certain of the wholesale voice services previously provided by 360networks (and by Zayo for the period between the completion of the Zayo *Pro Forma* Transactions and the Onvoy *Pro Forma* Transaction).
