

Q. Please state your name and business address.

A. My name is Peter Scott. My business address is 1000 South Highway 80, Benson, Arizona 85602.

Q. By whom are you employed and in what capacity?

A. I am the Chief Financial Officer for Sierra Southwest Cooperative Services (“Sierra Southwest”) and, as such, I supervise the financial activities of the cooperative. In addition, under agreements that Sierra Southwest has with Arizona Electric Power Cooperative, Inc. (“AEPCO”) and Southwest Transmission Cooperative, Inc. (“SWTC”), I am responsible for the same functions, as well as rate design and implementation, for these two cooperatives. As Chief Financial Officer, I serve on the Division Managers Group and report directly to the Chief Executive Officer. My specific responsibilities for AEPCO include establishing fiscal policy, procedures development and implementation of appropriate financial controls. I am also responsible for financial planning, rate design development and implementation, corporate treasury functions, as well as cash and working capital management and inventory control.
